ANNOUNCEMENT ON PROFIT ALERT FOR THE FIRST HALF OF 2022

This announcement is made by China Coal Energy Company Limited (the “**Company**” and, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) hereby informs the Company’s shareholders and potential investors that based on preliminary estimates of the unaudited consolidated management accounts of the Group in accordance with International Accounting Standard 34, the profit attributable to equity holders of the Company for the six months ended 30 June 2022 is expected to range from RMB13,420 million to RMB14,820 million (same period of 2021: RMB 8,545 million), representing a year-on-year increase of 57.1% to 73.4%.

The Board considers that the expected increase in profit for the six months ended 30 June 2022 is due to the facts that: in the first half of 2022, the Group a made full effort to increase production and supply to ensure the supply of energy and continued to enhance the scientific control expenses through refined management, the price of major products maintained at a high level, and the profit attributable to the associates of the Group increased, which led to a significant year-on-year increase in the results of the Group.

The information in this announcement is based on preliminary estimates by the management of the Company with reference to the consolidated management accounts of the Group in accordance with International Accounting Standard 34 and has not been audited by auditors. Detailed accurate financial statistics will be disclosed in the Company’s 2022 interim results announcement for the six months ended 30 June 2022 to be published before the end of August 2022.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
